With reference to the letter No. Surendranagar University / mentiononwebsite/002/2021 dated 14.06.2021 on the subject cited above, I am directed to inform you that the UGC has received thehas received **Gujarat Act No.15 of 2021 (Notification No.Vol.LXII dated 22<sup>nd</sup> May, 2021)** wherein Surendranagar University, Shree Pandit Nathulalji Vyas Technical Campus, Surendranagar-Ahmedabad Highway, Nr. Kothariya Village, At Wadhwan – 363030, Gujarat has been established as a Private University with effect from **01.06.2021** (**Notification No.GH/SH/14/EPU/2020/10012020/KH-1 dated 02.06.2021)**. In view of the establishment of Surendranagar University, Shree Pandit Nathulalji Vyas Technical Campus, Surendranagar-Ahmedabad Highway, Nr. Kothariya Village, At Wadhwan – 363030, Gujarat by the Act, the name of the University has been included in the list of Universities established as per section 2(f) of UGC Act. 1956 as maintained by the UGC on its website <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>.

- 1. The inclusion of the name of the University in the list of Universities maintained by the UGC does not by itself allow the University to make admissions in its programmes. This may be done only after creation of required academic and physical infrastructure facilities, including library, laboratories and appointment of teaching and supporting staff as per the norms and standards laid down by the UGC and Statutory Council(s) concerned.
- 2. The University is now requested to submit detailed information in the enclosed format (Annexure-I)(soft copy as well as hard copy) along with supporting documents duly attested by the Registrar of the University within a period of 3 months from the receipt of this letter. This format along with appendices is also available on the UGC website <a href="https://www.ugc.ac.in">www.ugc.ac.in</a>. The University is also requested to upload this filled in format and appendices on its website by giving a link on the home page so that the information is accessible to the students and general public.

- 3. After receipt of the Information in the above mentioned format, the following procedure would be adopted by the UGC for inspection of the University:-
  - (a) The information received from the University in the prescribed format would be posted on the UGC website within 10 days of the receipt of the information (Annexure-I). Comments would be invited from the general public within 1 month thereafter about the information submitted by the University. The comments received from the general public would be placed before the visiting UGC Expert Committee for perusal.
  - (b) An Expert Committee would be constituted by the UGC to ascertain whether the University fulfils the criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down from time to time by the UGC and other concerned statutory bodies such as AICTE, BCI, MCI, DCI, INC, NCTE, PCI, etc.
  - (c) The UGC Expert Committee would visit the University within 3 months of the receipt of the information (Annexure-I) for on the spot assessment of infrastructure and other facilities available with the University. The report submitted by the UGC Expert Committee would be sent to the University within 2 weeks of the completion of the visit for comments.
  - (d) The University may respond to the report within a period of two weeks after its receipt. In case no comments are received from the University within the timeframe, it would be presumed that the University has no comments to offer and further action would be taken on the report. After receipt of comments from the University, the report and comments received from the University, if any, would be placed before a Standing Committee of the UGC. The recommendations of the Standing Committee would be then placed before the Commission for consideration.
  - (e) The Commission shall take final decision in the matter. It may require the University to submit further compliance report in respect of the observations/suggestions of the UGC Expert Committee/Standing Committee. The compliance report submitted by the University shall be placed before the Commission for consideration.
  - (f) On approval of the Commission, aletter would be issued by the UGC to the effect that the University fulfills the criteria in terms of programmes, faculty, infrastructural facilities, financial viability, etc. as laid down from time to time by the UGC and other concerned statutory bodies.
  - (g) If it is found that the Private University has, even after getting an opportunity to do so, failed to comply with the provisions of the various UGC Regulations including UGC (Establishment of and maintenance of standards in Private Universities) Regulations, 2003 and suggestions given by the UGC Expert Committee, the Commission may pass an order prohibiting the University from offering any course for the award of the degree and/or the post-graduate degree/diploma, as the case may be, till the deficiency is rectified.
  - (h) The UGC may also take necessary action against a University awarding a first degree and /or a post-graduate degree, which are not specified by the UGC and inform the public in general through a public notification.
- 4. As per the judgment of the Hon'ble Supreme Court in the case of Prof. YashpalVs.State of Chhattisgarh, there is no provision to have Regional Centres/off-campus centres beyond the territorial jurisdiction of the State. In view of the judgement of Hon'ble apex court, the University is requested to adhere to the following:
  - a. No off-campus centre(s) is opened by the University outside the territorial jurisdiction of the State in view of the judgement of Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh.

- b. In case the University has already started any off campus centre outside the State, it must be closed down immediately. It may also be ensured that any off campus centre within the State shall be opened only as per the provision laid down in the UGC (Establishment of and maintenance of standards in Private Universities) Regulations, 2003 and with the prior approval of UGC.
- c. The University shall not have any affiliated Colleges.
- d. The University must ensure that there is no franchising of higher education even for the purpose of distance education.
- e. The University has to follow UGC (Minimum standards and procedure for award of M.Phil/Ph.D. degree) Regulations, 2016, as amended from time to time.
- 5. No Open and Distance Learning programmes and on-line programmes shall be started without the prior recognition of UGC. Relevant UGC Regulations are available on the UGC website www.ugc.ac.in.
- 6. The University is required to follow the UGC (Establishment of and Maintenance of Standards in Private Universities) Regulation, 2003 and other Regulations issued from time to time and posted on UGC website <a href="www.ugc.ac.in">www.ugc.ac.in</a>.

With reference to your letters No. Surendranagar University/Uni. Details/003/2021 & Surendranagar University/mentionon website/005/2021dated 14.06.2021 & 20.07.2021 on the above subject, I am directed to inform you that Surendranagar University, Shree Pandit Nathulalji Vyas Technical Campus, Surendranagar-Ahmedabad Highway, Nr.Kothariya Village, At Wadhwan, Gujarat has been established by an Act of State Legislature of Gujarat has a Private University and is empowered to award degrees as specified under Section 22 of the UGC Act, 1956 to the students studying in its main campus in regular mode with the approval of Statutory Bodies of the University and Statutory Councils, wherever it is required, after creating required academic and physical infrastructure facilities including library, laboratories and appointment of teaching and supporting staffs as per the norms and standards laid down by UGC and other relevant Statutory Council (s). The name of the University has been included in the list of Universities established as per section 2 (f) of the UGC Act, 1956.

Surendranagar University, Shree Pandit Nathulalji Vyas Technical Campus, Surendranagar-Ahmedabad Highway, Nr.Kothariya Village, At Wadhwan, Gujarat is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not granted any approval to the University to open off campus/study centre.

The University cannot offer its programmes through franchising arrangement with Private coaching institutions even for the purpose of conducting of courses through distance mode.

## Acts of Gujarat Legislature and Ordinances promulgated and Regulations made by the Governor

The following Act of the Gujarat Legislature, having been assented to by the Governor on the 13<sup>th</sup> May, 2021 is hereby published for general information.

#### **GUJARAT ACT NO. 15 OF 2021**

(First published, after having received the assent of the Governor, in the "Gujarat Government Gazette", on the 22<sup>nd</sup> May, 2021).

#### AN ACT

further to amend the Gujarat Private Universities Act, 2009.

WHEREAS the Sarvajanik Education Society, Surat, Vanita Vishram, Surat, Shri Krishna Educational and Charitable Trust, Vadodara, Shiv Shakti Ashish Trust, Surendranagar, Ankleshwar Rotary Education Society, Bharuch, Shri G.N.Patel Education & Charitable Trust, Rajkot and Shree Monark Education Trust, Ahmedabad have applied to the State Government under the provisions of the Gujarat Private Universities Act, 2009 to establish Private Universities in the State:

Guj. 8 of 2009.

IV- Ex.18 18-1

Guj. 8 of 2009.

AND WHEREAS the said applications have been scrutinised by the Scrutiny Committee and on the report of the Scrutiny Committee, the State Government has issued the Letter of Intent to the respective sponsoring body for establishment of the Private University;

AND WHEREAS the State Government is satisfied that the sponsoring bodies have complied with the conditions of Letter of Intent as provided in section 10 of the said Act and have also established the Endowment fund as per the Letter of Intent;

AND WHEREAS the State Government is committed to improving the Ease of Doing Business in all sectors.

AND WHEREAS it is considered necessary to have transparent working and good governance in the Education sector also and for that certain provisions of the said Act are required to be amended so as to minimize the regulatory compliance burden.

NOW, THEREFORE, the Government of Gujarat, in accordance with the provisions of section 10 of the Act, includes the institutions specified in column 2 of the Schedule as the Private University, by the name and location of the aforesaid sponsoring bodies as specified in column 4 of the said Schedule.

It is hereby enacted in the Seventy-second Year of the Republic of India as follows:-

## Short title and commencement.

- 1. (1) This Act may be called the Gujarat Private Universities (Amendment) Act, 2021.
- (2) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, appoint.

Amendment of section 3 of Guj. 8 of 2009.

- 2. In the Gujarat Private Universities Act, 2009 (hereinafter referred to as "the principal Act"), in section 3,-
- (1) in sub-section (5), the words "except the grant-in-aid colleges and institutions" shall be deleted;
  - (2) sub-section (7) shall be deleted.

**3.** In the principal Act, in section 4, for the existing proviso, the following proviso shall be substituted, namely:-

Amendment of section 4 of Guj. 8 of 2009.

"Provided that notwithstanding anything contained in this Act and save as provided in any Central Act, the University shall be eligible to undertake the functions of disseminating of knowledge in any fields after the Government issues Letter of Intent.".

**4.** In the principal Act, in section 5, in clause (xiii), the words "subject to the approval of the regulatory body" shall be added at the end.

Amendment of section 5 of Guj. 8 of 2009.

5. In the principal Act, in section 10, the words "subsequent to which the University shall function independent of the Sponsoring Body with all powers vested in the Board of the Governors of the University" shall be added at the end.

Amendment of section 10 of Guj. 8 of 2009.

**6.** In the principal Act, in section 14, in sub-section (1), the words "The President may be reappointed for the subsequent years." shall be added at the end.

Amendment of section 14 of Guj. 8 of 2009.

7. In the principal Act, section 33 shall be deleted.

Deletion of section 33 of Guj. 8 of 2009.

- 8. In the principal Act, in section 34,-
  - (1) the words "within five years of its establishment", shall be deleted;

Amendment of section 34 of Guj. 8 of 2009.

- (2) for the words "from time to time" the words "as may be required" shall be substituted.
- 9. In the principal Act, section 41 shall be deleted.

Deletion of section 41 of Guj. 8 of 2009.

10. In the principal Act, in section 42,-

Amendment of section 42 of Guj. 8 of 2009.

- (1) in sub-section (1), for the words "The Sponsoring Body who intends to dissolve the University", the words "If the Board of Governors intends to dissolve/merge the University, it" shall be substituted;
- (2) in sub-section (2), the words "in the sponsoring Body" shall be deleted.

Amendment of section 43 of Guj. 8 of 2009.

11. In the principal Act, in section 43, in sub-section (8), for the words "in the sponsoring Body", the words "in such manner as may be prescribed" shall be substituted.

Amendment of Schedule to Guj. 8 of 2009.

- 12. In the principal Act, in the Schedule,-

Please kindly ensure, to have adequate Law, Social Science, Computer, English faculty members in the ratio of 1 faculty per 40 students. Also ensure to have a qualified Librarian. Also ensure that no class room is below 750 Sq. ft.

If these conditions are not complied with, the approval of affiliation may be withdrawn at any time.

You may kindly bear in mind that the Bar Council of India is the sole and supreme sanctioning authority for seats and it does not allow any supernumerary quota of seats for law degree courses, over and above the sanctioned strength of seats and whatever reservation of seats is to done by the University under whichever quota as a rule has to be done within sanctioned strength of seats. The only supernumerary quota, as of now permitted by the Bar Council of India, is 10 percent seats in EWS quota over and above the sanctioned strength of seats allotted/approved by BCI and that too, is subject to adequate infrastructure and qualified faculty to accommodate the supernumerary seats. The same is required to be adhered to. If there is any default on such part and the same is discovered subsequently, action shall ensue which includes revocation of approval granted.

- 1. The Institution will maintain the staff, clinical and other teaching learning facilities required as per the norms for the course.
- 2. Change in address, place of school/ college shall be allowed only with the permission of council.
- 3. The course of studies and the scheme of examinations as prescribed by the council is to be followed strictly. The eligibility to appear in the examination will be as per INC norms.
- 4. Fresh permission will be required, if the institution fails to admit students in the academic year of permission.
- 5. The institution must agree for the inspection to be carried out on behalf of council as and when required.
- 6. Permission must be taken to admit a new batch every year till the first batch passes out, for which the institution should send necessary documents by month of April every year.
- 7. The affiliation and inspection fees as prescribed by the council from time to time shall be paid by the institution.
- 8. Institute must furnish such reports, returns and other information as asked by council from time to time.
- 9. The number of students will not be more than that allowed by the council.

- 10. The minimum requirement of admission is as prescribed by Indian Nursing Council and Gujarat Nursing Council from time to time. The procedure of admission shall be as prescribed by State Government. Student admitted through duly admission procedure only will be accepted.
- 11. Institutions will be responsible to verify the educational qualification, physical fitness etc. of the candidates and only those who fulfill minimum requirements for admission as fixed by the council shall be admitted.
- 12. The teaching learning and hostel facilities must be maintained as required. It will be verified at any time without prior notice and on the evaluation of such verification reports if the council is of the opinion that the facilities and training at the institution is not adequate for the training or is not maintained properly and the teaching learning activities are not carried out as it is required, the council may withdraw the permission and remove your institution from the list of approved training institutions.
- 13. All correspondence shall be addressed to the Registrar, Gujarat Nursing Council.
- 14. Physical facilities, clinical facilities, nursing teaching staff and other regulations as laid down by the Indian Nursing Council and Gujarat Nursing Council should be followed.
